Emergency overview

4. First aid measures

7. Handling and storage

Handling

: Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product may spontaneously self-ignite. To avoid the risks of fires, all contaminated materials should be placed in a metal container filled with water and sealed. Contaminated materials should be removed from the workplace at the end of each working day and be stored outside. Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Do not swallow. Do not get in eyes or on skin or clothing. Storage
